# DAVIS MOUNTAINS PROPERTY OWNERS ASSOCIATION, INC. BOARD OF DIRECTOR'S MONTHLY MEETING FEBRUARY 11, 2012

President Steve Barr called the meeting to order at 2:02 PM. Eligibility of members and posting of the Agenda were verified. Board members present; Steve Barr, Phyllis Arp, Joe Rowe, Marti Fellers, Jeff Smith, Chuck Smith, Tamara Mayo, Sandra Holzheuser. Board members absent Ken Gossett and Rick Draheim. With our Secretary absent Marti Fellers is appointed as acting Secretary for this meeting.

Marti Fellers read the minutes of the January 12, 2012 monthly meeting. Joe Rowe makes motion to approve the minutes as corrected. Seconded by Jeff Smith. Motion carried.

Joe Rowe gave Treasurers Report. Jeff Smith makes motion to accept the report and pay the bills. Seconded by Chuck Smith. Motion carried.

Joe Rowe gave the Road Committee Report. The Board discusses the use of a water mixed emulsion to use in a test area of the road to see if it would help with erosion control. Cost would be \$1000.00 for 300 gallons. Phyllis Arp makes the motion to give the Road Committee the \$1000.00 budget for purchase of the emulsion to do local research, motion is withdrawn. Joe Rowe and Chuck Smith will continue with research on the product and give an updated report at the March 10, 2012 regular meeting. Discussion of the purchase of Speed Bumps came to the conclusion that they are too expensive and that the Road Crew would make dirt berms instead. Chuck Smith makes the motion to accept the Road Committee Report, seconded by Joe Rowe. Motion carried.

DMPOA, Inc VFD. No report as the Fire Chief and members of the Department are at Annual Fire Training in Fort Davis.

### Budget Committee Report:

Revision of the 2011-2012 Budget. Joe Rowe gave the report on the Revisions made by the Budget Committee on the 2011-2012 Budget. Joe Rowe makes the motion to approve the Revised Budget, seconded by Phyllis Arp. Sandra Holzheuser abstains. Motion carries.

Investment of the Equipment Fund. Joe Rowe starts discussion for moving the fund for a higher interest rate. Sandra Holzheuser makes the motion that all of the Equipment Fund be transferred to State Farm into a Money Market Account. Jeff Smith seconded. All monies to be deposited in the future will be deposited into this same account. Motion carried.

Joe Rowe presents the Resolution Committee Report.

There has been no response from 5 property owners. Chuck Smith makes the motion that the board approve the Resolution Committee to contact our attorney, Richard Baker, and authorize him to proceed with foreclosure on these properties which the Resolution Committee has been unable to reach a settlement agreement with concerning their past due assessments. Motion seconded by Joe Rowe. Motion carried unanimously.
