The employee disciplinary procedures were reviewed, discussed, and a motion to pass them was made by Barbara House, seconded by Willis LeJeune, and passed.

The vacant Board position was addressed. Willis LeJeune nominated Cindy Davis, seconded by Barbara House. There were no volunteers from the floor. Cindy Davis was unanimously voted into that position, and accepted.

The Board went into Executive Session at 3:05 P.M. Discussion was held on personnel issues, and no action was taken. The Board meeting resumed at 3:05 P.M.

Microphone equipment that had been tested throughout the meeting was purchased from Julian Pierce on a motion by Sandra Holzheuser, Seconded by Cindy Davis, and passed. Mr. Pierce donated a wire also.

Open comments were made by DMR Fire chief Mike Fryer to remind people that this is an active fire season, and to clear around homes for 50 feet, and to cut off

branches at five feet or so. He stated that if you smell smoke call 911 or call him, and someone will check it out. He also said that the new brush truck is ready to go. Two new fire fighters from the Ft Davis VFD were introduced. Stuart Billingsley, and wife Sandy were gratefully accepted into the DMR VFD at their last meeting. They have recently become DMR property owners, and plan to also keep up their Ft. Davis fire fighting duties. Sam House announced his upcoming gardening meeting on March 19. Steve Barr praised the new sound system. Jim Ohlsen invited people to the Ft. Davis library for his noon presentation on astronomy on March 15.

Sandra Holzheuer made a motion to adjourn, seconded by Jackie Edwards, the motion passed, and the meeting adjourned at 3:30 P.M.
