There were no other people expressing a desire to be on the Board. Jackie made the motion to appoint Mariel, seconded by Willis, and passed unanimously.

There was some discussion about the need to contact the Game Warden, Mr. Freeman stated that would be addressed. Maria LeJeune announced the coming Art Walk in Alpine. Edna Queen announced the Thanksgiving dinner for the next day, and the VFD Christmas dinner on 12/16, and reminded the VFD support group about their upcoming meeting. David Wilson volunteered to help with the Feral Hog Committee. A thank you and round of applause was given to our Veterans who were invited to the party after the meeting. Willis motioned to adjourn, seconded by Janette, and the meeting closed at 2:40 P.M.
