Monthly Board of Director's Meeting October 8, 2022

The meeting was called to order by Dale Learish at 2:03 pm, a quorum was established and proper posting of the agenda was verified.

The invocation was led by Bill and the Pledge of Allegiance was led by Dale.

Jeff Fisher informed the board that meeting agendas needed to be posted 144 hours before Board of director's meetings and special board meeting 72 hours.

Minutes of September 10, 2022 Board Meeting: Secretary Jeff Fisher read the minutes from the September 10, 2022 DMPOA meeting. Bill motioned to approve the minutes as corrected. Chris seconded. The minutes were approved. Corrections: Sec. should be Tres.

Paul motioned to purchase 8 loads of caliche at 375.00 a load. Jeff Fisher seconded. Motion passed.

Hunting Signage: Jeff Fisher moved to have new sign made that says "Hunting is strictly prohibited, unless authorized by Texas law." and post at entrance to DMR. The issue was discussed. Wretha seconded. Motion passed.

DMRVFD Report: Presented by Edna Queen. (Report in file).

Jeff Fisher motioned to revisit Resolution committee report. Jeff Smith seconded. Motion passed. Paul brought up concerns about getting legal advice and privacy issues concerning delinquent property owners and other issues.

Open Comments: Wretha said the big sign at entrance of DMR needs some attention. There was discussion on hunting and the sign. Jan Van Liere presented a plan proposal to upgrade community center. Will be presented at November board meeting. Royce reminded everybody to vote.
